Pulse Asia Research, Inc. is pleased to share with you some findings on <u>the Performance</u> and <u>Trustworthiness of Top National Government Officials and the Performance of Key Government Institutions</u> from the September 2023 *Ulat ng Bayan* national survey. We request you to assist us in informing the public by disseminating this information.

The survey fieldwork was conducted from **September 10 to 14, 2023** using face-to-face interviews. This nationwide survey is based on a sample of 1,200 representative adults 18 years old and above. It has a \pm 2.8% error margin at the 95% confidence level. Subnational estimates for the geographic areas covered in the survey have the following error margins at 95% confidence level: \pm 5.7% for Metro Manila, the rest of Luzon, Visayas, and Mindanao. The following are some of the key developments during the weeks immediately prior to and during the conduct of the survey interviews:

- 1. The congressional deliberations regarding the P 5.7-trillion national budget for 2024, with the House Appropriations Committee approving the P 4.8 billion in confidential and intelligence funds requested by some government entities, including the Office of the President (OP), the Office of the Vice-President (OVP), and the Department of Education (DepEd);
- 2. The statement released by the Armed Forces of the Philippines (AFP) regarding the socalled "concerning resurgence of swarming activity" in the West Philippine Sea (WPS) as indicated by the presence of about three (3) dozens Chinese fishing vessels in the area in



late August 2023 and early September 2023 as well as efforts of Chinese vessels to block a Filipino resupply mission in Ayungin shoal;

- 3. The call made by the President during the 18th East Asia Summit held in Jakarta on 07 September 2023 to stop the "dangerous use" of coast guard and maritime militia vessels in contested areas in the South China Sea (SCS) and for stakeholders to adhere to international law in resolving territorial disputes in the SCS;
- 4. The rejection by the Philippines, along with India and Malaysia, of the 2023 standard map of China that includes the WPS as part of its territory as indicated by a 10-dash line, which encompasses the entire SCS and overlaps with the exclusive economic zones (EEZ) of the Philippines, Brunei, Indonesia, Malaysia, and Vietnam;
- 5. The new initiatives of the Department of National Defense (DND) to modernize the Philippine Navy and the Philippine Coast Guard amidst the continuing Chinese incursions into the WPS to be carried out through a comprehensive re-strategization and the forging of partnerships with allies;
- 6. The postponement of the administration's plan to import rice due to high prices in the world market and the projection made by the United States Department of Agriculture (USDA) that the Philippines' rice importation will reach 3.8 million metric tons for the marketing years 2023-2024, making it the top rice importer in the world;
- 7. The implementation of Executive Order (EO) No. 39, beginning 05 September 2023 and to last indefinitely, that sets the national price ceiling for regular milled rice at P 41/kilo and P 45/kilo for well-milled rice, a move that surprised members of the administration's economic team since they were not consulted on the matter;
- 8. The Department of Social Welfare and Development's (DSWD) distribution of cash assistance amounting to P 15,000 beginning 09 September 2023 to rice micro traders across the country who are affected by the cap on rice prices;
- 9. The release of the August 2023 inflation figures showing an increase in headline inflation from 4.7% in July 2023 to 5.3% in August 2023 primarily due to the higher increase in the prices of food and non-alcoholic beverages, with rice and vegetables being the main drivers in the increase in the inflation rate for food items;
- 10. The acquittal of Ms. Maria Ressa and Rappler Holdings Corporation over charges of tax evasion by the Pasig City Regional Trial Court Branch 157, this being the last of five (5) charges of tax evasion filed against Ms. Ressa and Rappler during the Duterte administration;
- 11. The distribution by the Land Transportation Franchising and Regulatory Board (LTFRB) of the P 3-billion fuel subsidy for public utility vehicle operators (PUV) beginning 13 September 2023, this following nine (9) consecutive weeks of oil price increases;
- 12. The filing of certificates of candidacy from 28 August to 02 September 2023 for the *barangay* and *Sangguniang Kabataan* elections to be held on 30 October 2023 and the launch

- on 08 September 2023 of the Committee on *Kontra Bigay* (CKB), the entity that will be responsible for implementing policies against vote buying and vote selling, among others;
- 13. The start of classes for academic year 2023-2024 in public schools across the country on 29 August 2023, with enrollment in elementary and high schools falling short of the DepEd target by around 2.5 million; while the Vice-President, who leads the department concurrently, blamed protest rallies for the shortfall, the Alliance of Concerned Teachers (ACT) attribute it to the shortage in classrooms, teachers, and education support personnel; prior to the start of classes, the Vice-President also called on teachers and school administrators to remove all wall decorations inside classrooms to avoid distracting students from their lessons;
- 14. The release of a DepEd memorandum dated 06 September 2023 requiring a change in the terms used in Grade 6 *Araling Panlipunan* curriculum on the martial law years from "diktadurang Marcos" (Marcos dictatorship) to simply "diktadura" (dictatorship), a move seen by critics of the DepEd as an effort to rebrand the Marcos family;
- 15. The expulsion of Negros Oriental Representative Arnolfo Teves, Jr. from the Lower House on 16 August 2023 and the issuance of a warrant of arrest for him on 05 September 2023 in connection with his role in the death of Negros Oriental Governor Roel Degamo and nine (9) other individuals in March 2023;
- 16. The deferral of the implementation of the revised departure guidelines for Filipino travelers, originally scheduled for implementation starting 03 September 2023, amidst concerns raised by lawmakers, migrant workers, human rights groups, the business community, and the public;
- 17. The recommendation made by the Office of the Ombudsman to file graft charges, instead of plunder, against former officials of the Procurement Service-Department of Budget and Management (PS-DBM) and officers of Pharmally Pharmaceutical Corporation in connection with the granting of various contracts to Pharmally for the delivery of medical supplies for the government's response to the COVID-19 pandemic; and
- 18. The suspension of 22 reclamation projects in Manila on 09 August 2023 in order for the Department of Environment and Natural Resources (DENR) to assess their environmental and social impacts as well as their compliance with relevant regulations.

Only two (2) of the leading Philippine government officials register majority approval ratings in September 2023

Most Filipino adults remain appreciative of the quarterly performance of the President and the Vice-President (65% and 73%, respectively). Both government officials also record majority approval scores in all geographic areas (60% to 73% and 63% to 87%, respectively) and socioeconomic groupings (53% to 68% and 54% to 76%, respectively). (*Please refer to Tables 1 to 2.*)

Half of the country's adult population (50%) has a positive assessment of the work done by Senate President Juan Miguel F. Zubiri while the same percentage of Filipino adults (50%) are unable to say if they approve or disapprove of the performance of Supreme Court Chief Justice Alexander G. Gesmundo. In the case of House Speaker Ferdinand Martin G. Romualdez, he obtains essentially the same approval and indecision ratings (41% versus 44%). The disapproval ratings of the country's top national government officials vary from 5% for the Vice-President to 16% for the Supreme Court Chief Justice. (*Please refer to Table 1*.)

Appreciation is the predominant sentiment toward the work of Senate President Zubiri among Visayans (61%), Mindanawons (63%), and those belonging to Classes D and E (51% and 52%, respectively). In the rest of Luzon and Class ABC, small majorities cannot say if they approve or disapprove of the latter's performance (53% and 54%, respectively). The same percentage of Metro Manilans (42%) either approve of the lawmaker's work or are ambivalent on the matter. (*Please refer to Table 2*.)

The only majority approval rating of House Speaker Romualdez is granted by Visayans (64%). Ambivalence concerning the lawmaker's quarterly performance is the plurality sentiment in Metro Manila and the rest of Luzon (47% and 49%, respectively). About the same approval and indecision figures are registered by the latter in Mindanao (38% versus 45%), Class D (42% versus 46%), and Class E (41% versus 44%). There is a three-way split in the House Speaker's performance ratings in Class ABC (i.e., 36% approval, 34% indecision, and 30% disapproval).

Supreme Court Chief Justice Gesmundo obtains majority indecision scores in Metro Manila (65%), the rest of Luzon (53%), and Class E (59%). Ambivalence on the matter of trusting or distrusting the latter is expressed by near majorities in Mindanao (46%) and Class D (50%). The Supreme Court Chief Justice has nearly the same approval and indecision ratings in the Visayas (49% versus 43%) and Class ABC (35% versus 44%).



Approval for the performance of the country's key government officials eases between June 2023 and September 2023

Although the President and the Vice-President continue to enjoy majority approval scores at the national level and across geographic areas and socio-economic classes, both experience significant erosions in their respective approval ratings during the period June 2023 to September 2023. Levels of approval for the President's work decline in the Philippines as a whole (-15 percentage points) and in all areas and classes (-14 to -15 percentage points and -12 to -29 percentage points, respectively). As for the Vice-President, her approval ratings drop at the national level (-11 percentage points) as well as in Metro Manila (-12 percentage points), the rest of Luzon (-13 percentage points), Class ABC (-18 percentage points), and Class D (-11 percentage points). (*Please refer to Table 3.*)

The only notable change in the performance ratings of Senate President Zubiri is the decline in his overall approval rating (-6 percentage points). Meanwhile, the approval scores of House Speaker Romualdez decrease not only in the Philippines (-11 percentage points) but also in Metro Manila (-14 percentage points), the rest of Luzon (-12 percentage points), Mindanao (-15 percentage points), and Class D (-13 percentage points). Similarly, appreciation for the work of Supreme Court Chief Justice Gesmundo eases among Filipino adults (-10 percentage points) and Metro Manilans (-16 percentage points), Mindanawons (-13 percentage points), and those in Classes D and E (-9 and -29 percentage points, respectively).

Ambivalence becomes more pronounced toward the performance of the President (+8 percentage points), the Vice-President (+8 percentage points), and Supreme Court Chief Justice Gesmundo (+7 percentage points). In addition, presidential indecision figures go up in the Visayas (+12 percentage points) and Class E (+24 percentage points) while ambivalence regarding vice-presidential performance becomes more notable in Class D (+9 percentage points). The only significant change in the indecision figures of House Speaker Romualdez occurs in Class D (+8 percentage points). As for ambivalence about the Supreme Court Chief Justice's performance, it becomes more marked in Metro Manila (+21 percentage points), Class D (+8 percentage points), and Class E (+24 percentage points) but it eases in Class ABC (-22 percentage points).

Regarding these government officials' disapproval ratings, the only significant changes at the national level are recorded by the President (+6 percentage points) and the House Speaker (+6 percentage points). Across areas and classes, it is only the House Speaker who experienced a significant change (+20 percentage points in Class ABC).

Trust is the prevailing sentiment only toward the President and the Vice-President

Majority trust ratings are enjoyed by the President and the Vice-President in September 2023 (71% and 75%, respectively). Senate President Zubiri has nearly the same trust and indecision figures (49% versus 44%) while ambivalence toward their trustworthiness is the plurality sentiment toward House Speaker Romualdez (48%) and Supreme Court Chief Justice Gesmundo (47%). The overall distrust figures of these national government officials vary from 5% for the Vice-President to 20% for the Supreme Court Chief Justice. (*Please refer to Table 4.*)

The President and the Vice-President record majority trust scores in every geographic area (68% to 77% and 64% to 92%, respectively) and socio-economic grouping (56% to 74% and 61% to 77%, respectively). For the Senate President, trust is the majority sentiment toward him in the Visayas (59%) and Mindanao (57%) while most of those in the rest of Luzon cannot say if they trust or distrust him (54%). Virtually the same trust and indecision ratings are obtained by Senate President Zubiri in Metro Manila (47% versus 46%) and all classes (44% to 49% versus 42% to 45%). (*Please refer to Table 5.*)

House Speaker Romualdez enjoys a majority trust score only in the Visayas (58%) while he records majority indecision figures in Metro Manila (52%) and the rest of Luzon (56%). Moreover, ambivalence about the lawmaker's trustworthiness is the plurality sentiment in Class D (49%). Basically the same trust and indecision ratings are recorded by the House Speaker in Mindanao (34% versus 42%) and Class E (38% versus 45%) while there is a three-way split in Class ABC (i.e., 38% trust, 39% indecision, and 23% distrust).

Most Metro Manilans (70%) and those in the rest of Luzon (56%) are unable to say if they trust or distrust Supreme Court Chief Justice Gesmundo. Near majorities in Classes D and E share this sentiment (48% and 49%, respectively). On the other hand, half of Visayans (50%) trust the latter. About the same trust and indecision figures are posted in Mindanao (35% versus 39%) while a three-way split may be observed in Class ABC (i.e., 37% trust, 35% indecision, and 28% distrust).

The overall trust ratings of the country's leading government officials drop between June 2023 and September 2023

Despite recording majority trust ratings in September 2023, trust in the President and the Vice-President eases at the national level from June 2023 to September 2023 (-14 and -12 percentage points, respectively). Furthermore, the President's trust scores decline in the rest of Luzon (-20 percentage points), the Visayas (-13 percentage points), and every socioeconomic class (-13 to -21 percentage points). In the case of the Vice-President, trust in her becomes less notable in the rest of Luzon (-18 percentage points) and Class D (-13 percentage points). (*Please refer to Table 6.*)

Likewise, the trust scores of the other key government officials decline during the same period. Trust in Senate President Zubiri becomes less pronounced in the Philippines (-8 percentage points), Mindanao (-17 percentage points), and Class E (-15 percentage points). The trust ratings of House Speaker Romualdez decrease not only at the national level (-16 percentage points) but also in Metro Manila (-14 percentage points), the rest of Luzon (-18 percentage points), Mindanao (-21 percentage points), and Class D (-16 percentage points). And in the case of Supreme Court Chief Justice Gesmundo, levels of trust in him decline among Filipino adults (-10 percentage points), Metro Manilans (-23 percentage points), those in the rest of Luzon (-15 percentage points), and those in Classes D and E (-10 and -17 percentage points, respectively).

Overall levels of ambivalence toward the trustworthiness of the following officials rise between June 2023 and September 2023 – the President (+12 percentage points), the Vice-President (+10 percentage points), Senate President Zubiri (+9 percentage points), and House Speaker Romualdez (+12 percentage points). Essentially the same national figures are recorded by Supreme Court Chief Justice Gesmundo in June 2023 and September 2023 (46% versus 47%).

Across areas and classes, ambivalence toward presidential trustworthiness becomes more notable in the rest of Luzon (+19 percentage points), the Visayas (+13 percentage points), and every socio-economic grouping (+11 to +25 percentage points). The Vice-President's indecision figures increase in the rest of Luzon (+16 percentage points) and Class D (+11 percentage points) while ambivalence regarding the trustworthiness of the Senate President becomes more pronounced in the rest of Luzon (+14 percentage points), Mindanao (+15 percentage points), and Class D (+8 percentage points).

House Speaker Romualdez's indecision scores go up in the rest of Luzon (+19 percentage points) and Class D (+13 percentage points). While ambivalence about the trustworthiness of Supreme Court Chief Justice Gesmundo becomes more marked in Metro Manila (+21 percentage points), the reverse holds true in the Visayas (-17 percentage points) and Class ABC (-22 percentage points).

As regards distrust in these top government officials, there are few movements between June 2023 and September 2023. Levels of distrust in the Supreme Court Chief Justice go up at the national level (+9 percentage points) and in Class ABC (+24 percentage points). As for House Speaker Romualdez, distrust in him becomes more pronounced among Mindanawons (+13 percentage points).

Near to small majority approval ratings are registered by key government institutions in September 2023; few changes in the performance ratings of these entities occur between June 2023 and September 2023

Small majority approval scores are enjoyed by the Senate (59%) and the House of Representatives (54%). Nearly half of Filipino adults also have a positive opinion about the work done by the Supreme Court (49%). These figures are essentially the same as those recorded in the June 2023 *Ulat ng Bayan* survey. (*Please refer to Tables 7 to 8.*)

The Senate enjoys majority approval figures in every geographic area (52% to 69%) and Classes D and E (59% to 61%). Most Metro Manilans (53%), Visayans (65%), Mindanawons (64%), and those in Classes D and E (53% to 56%) have a positive assessment of the Lower House's performance. Majority approval ratings are obtained by the Supreme Court in the Visayas (70%) and Mindanao (62%). (*Please refer to Table 7*.)

About the same approval and indecision ratings are granted to the House of Representatives by those in the rest of Luzon (44% versus 46%). The same observation may be made for the Supreme Court in Metro Manila (40% versus 41%) and the rest of Luzon (35% versus 46%). Half of those in Class D (50%) are appreciative of the Supreme Court's performance. In Class ABC, there is a three-way split in the performance ratings of these institutions (i.e., 38% to 41% approval, 29% to 38% indecision, and 23% to 30% disapproval.

While the national performance ratings of these institutions are essentially unchanged during the period June 2023 to September 2023, there are a few significant movements across areas and classes. Appreciation for the Senate's performance becomes more notable in Mindanao (+12 percentage points) but eases in the Visayas (-17 percentage points) and Class ABC (-22 percentage points). Likewise, the Lower House's approval rating declines in Class ABC (-24 percentage points). The Supreme Court experiences an improvement in its approval score in Mindanao (+14 percentage points) but the opposite occurs in Metro Manila (-14 percentage points). (Please refer to Table 8.)

In the Visavas, ambivalence toward the performance of the Senate and the House of Representatives becomes more manifest (both at +15 percentage points). With respect to disapproval, the only significant movement is the increase in the Supreme Court's score in Class ABC (+18 percentage points).
